The original Remuneration Fee Bid of US\$ 12.50/boe was in excess of the Maximum Remuneration Fee (MRF) of US\$ 5.00/boe set by the Ministry of Oil. Sonangol originally declined the opportunity to match the MRF. However, after further clarification as to requirements for the transfer of the heavy crude oil from this Contract Area, Sonangol advised that it will match the MRF.

After this acceptance, Sonangol is declared winner of the bid for the Qaiyarah Contract Area.
